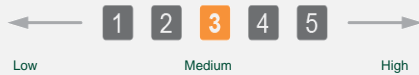

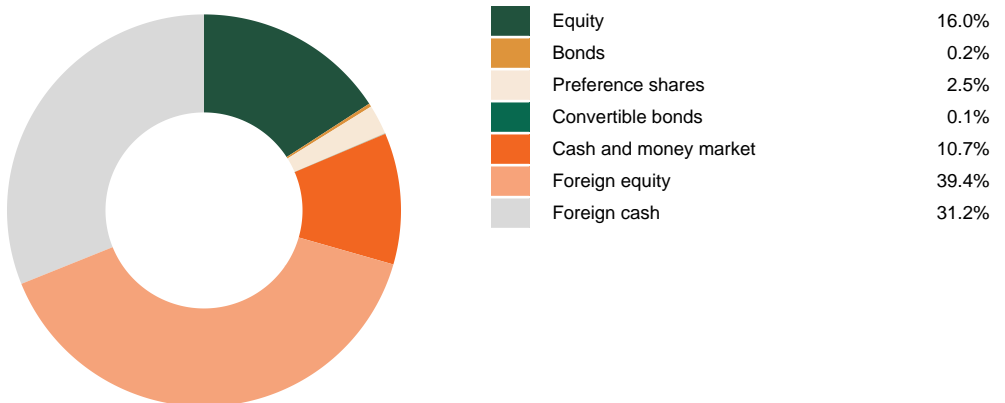

### Investment manager commentary

#### Aylett & Co

"When the facts change, I change my mind" - *John Maynard Keynes*

Until recently, our funds were positioned for a stronger Rand, an improving economy and increased exposure to South African assets.

All this changed with the firing of the two most senior officials at the Ministry of Finance. While we do not usually react to short-term political movements, we decided to increase our exposure to offshore assets; invest in stocks with rand hedged properties; and require a greater margin of safety from local counters.

To this end, we are scaling up our offshore holdings and identifying new stocks which will benefit from the change in the environment.

Our perception is that the market took the bad news quite well and the rand and bond market did not depreciate to the extent we expected it to. Perhaps the market was expecting a downgrade but for different reasons. We do not know how it will play out and what the correct course of action to take will be. We have decided to be prudent and implemented the above actions.

In conclusion, we are not as pessimistic as many of the commentators and while we understand the impact of the downgrade, the political environment may end up surprising us in the long run. The world seldom ends and this particularly difficult time will pass. Hopefully the market will overreact and provide us with buying opportunities with an adequate margin of safety. Our cash levels are quite high and ready to be invested.
