Our Investment Strategy and Philosophy

Shares are evaluated, not by a fluctuating ticker or a graph on a screen, but by what they represent, a certificate of ownership. We seek great businesses that are well run and managed, trading at a discount to their intrinsic value. We follow the adage that the return of an investment is determined not by the exit price but by the price one pays.

Fund Objective

The objective of the Aylett Equity Prescient Fund is to maximise long term capital appreciation by investing in assets on behalf of clients that will preserve their purchasing power in real terms and earn a satisfactory return on that capital.

Fund Universe

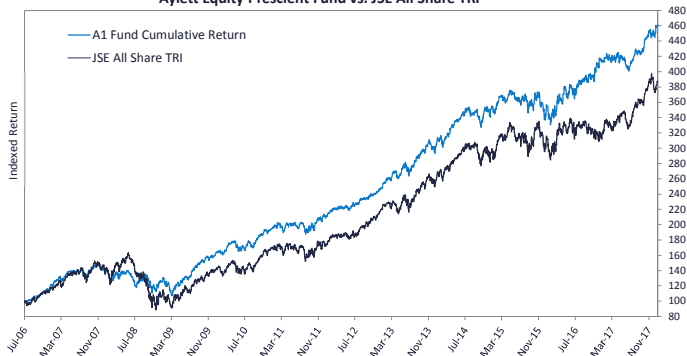
The Aylett Equity Prescient Fund is required to invest a minimum of 80% of the portfolio in equities at all times, with offshore asset exposure being limited to 25%.

The Fund has a moderate to high risk profile as it is actively managed across global equities, cash and listed assets.



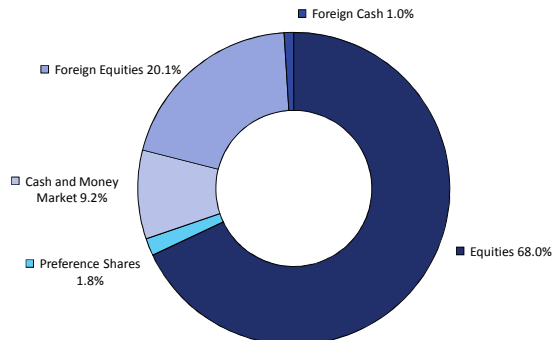
Aylett Equity Prescient Fund vs. JSE All Share TRI

Fund Manager Commentary:

On the face of it, the fund appeared to have a poor year relative to benchmarks and many of the competitors. However, on review, the underperformance essentially boiled down to not owning Naspers, a large constituent of all the major indices. Despite its heavy weighting, we have chosen not to hold Naspers for many years and our views are well known. Our philosophy remains not to hold shares simply because they are in the benchmark. An example of where this approach has benefited unit holders is the significant losses suffered by Steinhoff's shareholders in December. It has taken twelve years for our views about the company to be proven correct and we take no joy on being right about the outcome, but allocating capital is a serious business - something we passionately believe at Aylett and Co. As we saw with Steinhoff, once capital is permanently lost, it is very difficult for a portfolio to recover.

Most of our existing investments did well for us, including our new investment into a company called L Brands which is better known for its ownership of Victoria's Secret. The investments made in Asia continue to do well for us and remain relatively undervalued. There are some stocks that have been marked down by the market but we think this is temporary. The long term prospects remain positive. In addition, local companies such as RAC, Bowler, Transpaco and Long4Life have interesting prospects.

Looking forward, there appears to be little pessimism and all indicators point to investors believing the positive market momentum to continue. Cash is at an all-time low amongst investors, expected volatility is low and insurance for protection is cheap. Professional investors such as hedge funds have leveraged themselves to the highest levels in five years and numerous other indicators point to the abundance of optimism. Usually this can be a very dangerous time for investors. Our cautious stance of 2017 continues and we will try use some correction to introduce new ideas into the fund.

The local currency has strengthened, and on balance much of the positive news surrounding the new leader of the ANC has accounted for this. Our inclination is to use the recent strength to move additional cash offshore. Furthermore, stocks in South Africa had a good run in the last quarter and some pull-back may be required for us to invest. In the meantime, we will continue to focus the fund and make sure existing ideas are worthy of their position.
